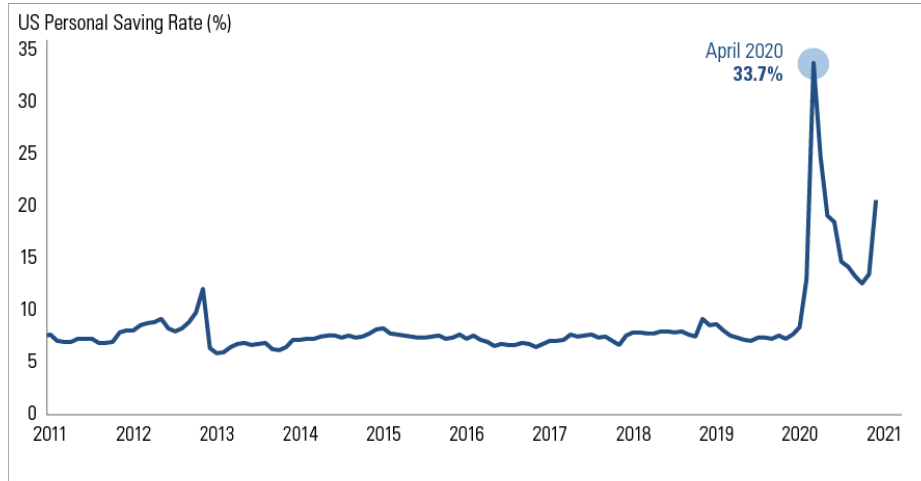

ECONOMY

During the pandemic, the personal savings rate soared as Americans elected to delay spending. Savings have declined recently but at 20.5% still stand at historic highs. With more businesses reopening and new stimulus checks from the Biden administration's \$1.9 Tn stimulus bill potentially hitting before month end, we believe pent-up demand and savings may further fuel the economic recovery.

MARKET SUMMARY

GLOBAL EQUITIES: While investors watched for another round of bond sell-offs, US fiscal stimulus and tepid inflation data drove the global equity market rally. The S&P 500 was up 2.69% last week, ending at a fresh record closing high, as President Biden signed the \$1.9 Tn "America Rescue Plan" stimulus package. Meanwhile, European equities welcomed the ECB's decision to increase the pace of PEPP purchases in response to the recent bond sell-off. The Euro STOXX 600 ended higher 3.56%.

COMMODITIES: Oil prices continued to rise on the back of an improved demand outlook. Yet oil price gains were offset by higher-than-expected US crude inventory build, an aftermath from Texas winter storm in February. WTI and Brent crude oil ended the week moderately lower at \$65.61 and \$69.22 per barrel, respectively.

ECONOMIC SUMMARY

MANUFACTURING: Euro area industrial production posted above expectations, rising by 0.8% month-over-month (MoM) in January. The higher print was mainly driven by production of durable consumer goods (+0.8% MoM).

SENTIMENT: The University of Michigan Consumer Sentiment Index jumped to a one-year high of 83.0, beating consensus expectations, in March's preliminary read. The broad optimism in consumer's assessment of current conditions occurred amid increased vaccinations and was conducted prior to the signing of the latest fiscal stimulus package.

FIXED INCOME: US 10-Year Treasury yield hit its highest level in a year, surpassing 1.64% during last Friday's trading, amid continued improvement in economic reopening, vaccinations, and labor market recovery. Yields also held up during last week's Treasury auction where sufficient demand eased concerns that the market would not be able to handle a growing debt burden. The 2-10 Treasury spread was at its highest level at 148 basis points since September 2015. The 10-Year UK Gilt yield followed suit, ending higher at 0.82%.

FX: The US dollar weakened 0.38% against a basket of major peers, as risk-on sentiment led traders to global markets and shrugged off pressure from rising bond yields on Friday. The British sterling and euro strengthened against the US dollar, ending at \$1.1949 and \$1.3923, respectively.

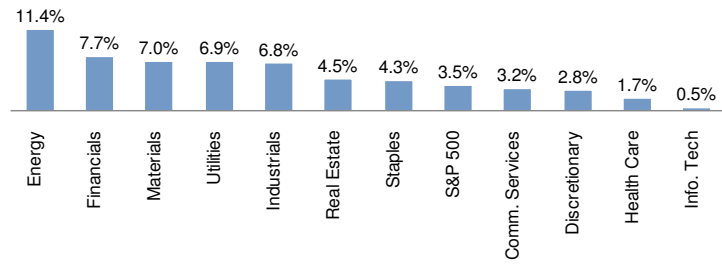
INFLATION: February's US CPI rose 0.1% MoM. The moderate read was largely driven by energy prices and offset by subdued demand for services. Core CPI rose 1.3% Year-over-Year (YoY) as recreational and medical care costs firmed. China CPI declined to -0.2% YoY in February, coming in slightly above consensus expectations. The decline was due to base effects, as COVID-19 pushed the price of consumer goods higher in February 2020.

JOBS: US initial jobless claims fell to 712k, lower than expected, for the week ending March 6, and continuing claims eased to 4.1Mn as the job market continues to recover.

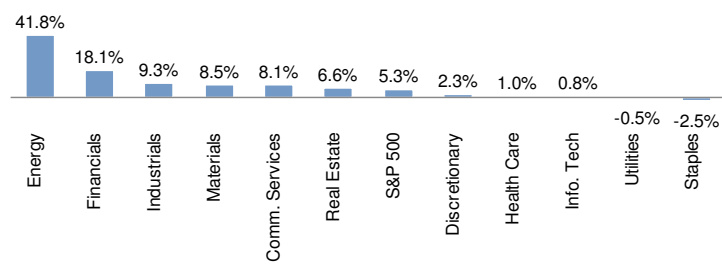

Month-to-Date, As of 03/12/21

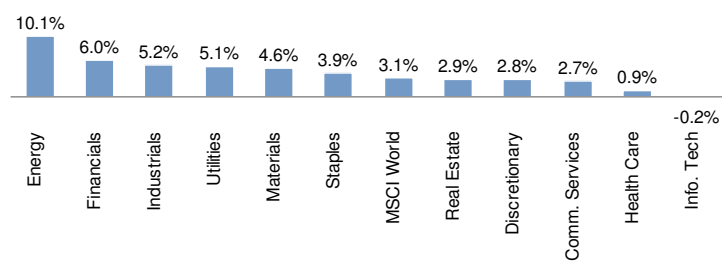


Year-to-Date, As of 03/12/21

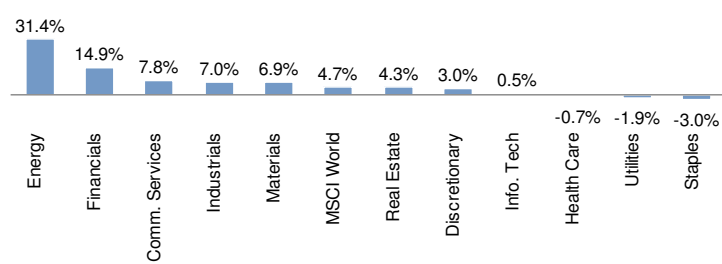


MSCI World Index Sector Returns

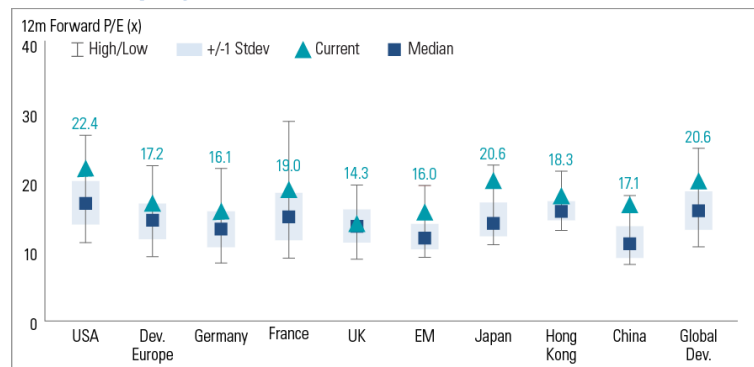

The **Financial Times Stock Exchange (FTSE) 100 Index** is an index of the 100 companies listed on the London Stock Exchange with the highest market capitalization. **FTSE MIB Index** is composed of 40 Italian equities and seeks to replicate the broad sector weights of the Italian stock market. **CAC 40 Index** is composed of the 40 largest equities listed in France. **SWISS Market Index** is composed of the largest and most liquid stocks traded on the Geneva, Zurich, and Basel Stock Exchanges. **Hang Seng Composite Index** covers about 95% of the total market capitalization of companies listed on the Main Board of the Hong Kong Stock Exchange. **MSCI World Index**, is a broad global equity index that represents large and mid-cap equity performance across 23 developed markets countries. The **S&P GSCI Commodity Index** is a composite index of commodity sector returns, representing an unleveraged, long-only investment in commodity futures that is broadly diversified across the spectrum of commodities. The **S&P 500 Consumer Staples Index** comprises those companies included in the S&P 500 that are classified as members of the GICS® consumer staples sector. The **German Bunds 2-Year** is a German debt obligation that has a maturity of 2 years. The **German Bunds 10-Year** is a German debt obligation that has a maturity of 10 years. The Japanese Govt Bonds 2-Year is a Japanese debt obligation that has a maturity of 2 years. The **Japanese Govt Bonds 10-Year** is a Japanese debt obligation that has a maturity of 10 years. The **UK Gilts 10-Year** is a UK debt obligation that has a maturity of 10 years. The **Swiss Govt Bonds 10-Year** is a Swiss debt obligation that has a maturity of 10 years. The **French OATs 10-Year** is a French debt obligation that has a maturity of 10 years. The **Italian BTPs 10-Year** is a Italian debt obligation that has a maturity of 10 years. The **Spanish Bonos 10-Year** is a Spanish debt obligation that has a maturity of 10 years.

Spreads

High Yield (HY) Corporate Spread is the Barclays US Corporate High Yield Average Option Adjusted Spread (OAS), which measures the spread between the US Treasury yield curve and the Barclays US Corporate High Yield curve. The **Bank Loan Spread** is the daily discount margin (3-year life) of the Credit Suisse Leveraged Loan Index, which is designed to mirror the investable universe of the USD-denominated leveraged loan market. The **Investment Grade (IG) Corporate Spread** is the Barclays US Aggregate Corporate Average OAS, which measures the spread between the US Treasury yield curve and the Barclays US Corporate Average curve. The **EMD Spread** is the J.P. Morgan EMBI Global Diversified Sovereign Spread, which measures the spread between the US Treasury yield curve and the J.P. Morgan EMBI Global Diversified Sovereign curve.
